RE: 500 Ministry Kids patients at Surrey Gender Clinic!

March 25, 2019

Dear Mr. Premier,

It is regrettable that you have failed to meet with those of us who continue to bring awareness to parents, educators and other stakeholders about the dangers associated with SOGI 123. Instead, you have allowed the voices of radical sex activists within your party to fill your head. If you cared enough about the children of this province you would have taken the time, and shown some interest in the information, research and personal experience parents have reported to us.

Perhaps this situation will warrant your attention. On February 28, 2019 I sent a team of volunteers to attend a meeting being held by a Dr. Wallace Wong. It was recorded and has now been transcribed and will form part of the legal record involving the 14-year-old child who has been deemed competent to consent to the experimental treatment BC Children's Hospital has determined to be "in her best interests."

That decision by the court is under appeal.

Dr. Wong is one of the doctors involved in the case. He also is one of the busiest BC doctors involved in treating and assessing children who are allegedly suffering from gender identity and dysphoria issues. I have received numerous reports of concern from other health care professionals about Dr. Wong, who is self-admittedly gay, and has no children of his own—and hence no practical experience in raising children or parenting.

At the event featuring Dr. Wong, a number of disturbing comments were made that demand a full inquiry into what is actually happening with and to the most vulnerable members of our society.

Throughout his introduction to his work, Dr. Wong explains how, when he first started seeing transgendered patients 20 years ago 90 percent were adults. He then talks about a second and a third

wave involving 14, 15, 16-year-olds. And now a 4th wave of much, much younger children.

E.g. (from the transcript): “Then I see younger kids. So, the younger kids come see me as young as three years old.” Dr. Wong goes on to say, “So the youngest patient that I have is two-and three-quarters old” (Wong transcript, page 9, lines 22-23)

While there is a large volume of distressing information in this transcript, some of the most concerning involves his unabashed use of the “suicide” card to get funding for his services. On page 69 & 70 of the transcript, Dr. Wong states:

Because in a way we’re teaching the kid, “You need to be sick enough. So what you need is, you know what? Pull a stunt. Suicide every time they will give you what you need.” They learn that. They learn it very fast right? If I want and need this, I just say, “Hey Mom,” right?

It is time to have a reality check, Mr. Premier. The reality of what is transpiring, and the research don’t support SOGI 123, nor the deliberate radical social experimentation and medical mutilation of our children. Reality demonstrates that among young adolescents—especially girls—that “transitioning” is a social contagion. SOGI123, and the current strategy to celebrate these troubled children, fuels the contagion. You, Mr. Premier, are deliberately making children sick, sterile, maimed and sentencing them to lifelong health consequences. ***STOP the Lunacy, end Gender-Jacking!***

The most troubling aspect to the revelations offered by Dr. Wong include his comments about his clientele. The information in this transcript ***demand***s a public inquiry and should result in safeguards being put into place to protect our children. In Australia children in the care of the government are ***prohibited*** from transitioning unless a court is willing to provide such an order.

On page 10 of the transcript, starting at line 18 thru line 22, Dr. Wong boasts about the radical growth his clinic has seen:

So, in our Gender Health Clinic, we start in two thousand—after 2010. So back then, we started with four clients at the Ministry. But now we have more than 500 kids, and just the Ministry alone.

Later, Dr. Wong says that, combining the number of patients in his private practice with the children he treats for the Ministry, there are currently more than 1,000 in Dr. Wong’s so-called ‘gender therapy’!

So, in this 500 of them, so we’re talking about in just, like, within ten years, that’s 125 times increase.

Page 70, in response to a question about his practice, Dr. Wong then goes on to clarify at line 13:

The 501 is from Surrey, Langley, Delta.

I trust that you have a measure of growing concern over what this translates into. If there are 501 kids from the “Ministry” (in government care), from just 3 geographical locations that are being recruited into the trans industry pipeline, we have a very serious situation that *must* be investigated by the proper authorities—the police.

I have contacted the Ministry of Children and Family Development and requested the protocol associated with children in care wanting to transition. Nobody seems to know how it works. Perhaps you will have better success in finding out.

As a former member of the Child and Family Review Board, a position that oversaw the rights of children in care, I am horrified by this explosive information.

The other important information you will note, in your read of the Wong transcript, is that he is aware that 80 percent of children desist, if left alone. But SOGI 123 does not leave them alone; it propels them along into the lucrative trans pipeline.

I would like to believe that you would agree that adults shouldn’t be getting rich by cutting off healthy body parts from children. Nor should Big Pharma profit and benefit from vulnerable children as lifelong clients because social workers are ignorant and fail to act in the best interests of their charges.
