RE: *Hudspeth v Whatcott et al*

Dear Prime Minister,

I have been informed by lawyer Douglas Elliott, via his August 12, 2016, "Press Conference," that you are a "Plaintiff" in the *Hudspeth et al v Whatcott et al* \$104 million dollar lawsuit. Further, as a member of a "class" of Toronto Pride marchers referred to in the "Statement of Claim" that you have suffered "mental distress," among other things, as a result of Mr. Whatcott and his fellow Zombies participation in that political event.

If this is the case, you should be aware that I am an avid supporter of our Constitution and the protection of rights contained therein. I am also a supporter of Mr. Whatcott. By confirming your status as a member of one of the identified classes in this ridiculous lawsuit, you are, in effect, confirming the views of your critics that you hold a contemptuous disregard for the democratic principles upon which this country was founded, and mock the liberty provisions within our Constitution and those who do not agree with you. Bill C16 is a perfect example.

I suggest you read the factum for the Defendant, William Whatcott. Unlike the lawyers representing you (as a co-Plaintiff), Mr. Whatcott's counsel take seriously the Rule of Law, and seek to protect the rights of Canadians. This factum is a brilliant insight into the law that protects our citizens, and it would be well worth your while to take the time to read it. It will provide you with a clear and deeper understanding of a Canadian's right to political protest and participation.

Of course I am assuming you want to uphold those rights. There is another reason you should read the factum: as a "Class" member there is a very good chance that you will have to address the points raised in the factum during

discovery and/or cross- examination. As Prime Minister, your responses will be of great interest to all Canadians—especially under these circumstances.

I'm also providing you with copies of my letters to 'your' class-action case's lawyer, Douglas Elliott—although he seems to have dropped off the radar in this case. It's my hope that you will begin to understand that your participation in this political stunt compromises the Office you occupy, and thereby threatens to undermine your credibility to the vast majority of Canadians.

I should advise you that despite my disclosure of support of Mr. Whatcott, your legal "team" found me to be unsuitable as a defendant. You should ask them why.

I've come to know that most of Mr. Elliott's claims have no basis of support whatsoever, and perhaps your participation in this vexatious political stunt is a figment of his hopeful imagination. Therefore, please confirm to me whether you, or your office, have approved your status as a member of a "class" affected by the "Zombies", and whether you have ever agreed to be named in this lawsuit.

If it happens that Mr. Elliott has misrepresented your position, I believe it would be prudent for you to set the record straight immediately.
