4. <u>BUSINESS ARISING FROM PUBLIC HEARING</u>

a. Bylaw 2992

Third and Final reading of a bylaw to amend the Zoning Bylaw.

Motion #16/132 MOVED BY Councillor Albrecht SECONDED BY Councillor Martin

THAT the bylaw cited as the "Zoning Bylaw 1996, No. 2100, Amendment no. 129 Bylaw, 2016, No. 2992" be read a third time.

Councillor Pachal stated he had heard from many members of the community and understands the importance of thrift stores. He suggested this issue should be revisited in five years to determine if it is still relevant to the community.

In response to a question, the Director of Development Services advised consignment stores are exempt from the bylaw as they do not receive and sell donated items.

Motion #16/133 MOVED BY Councillor Storteboom SECONDED BY Councillor Pachal

THAT the bylaw be amended to include a five year moratorium.

DEFEATED unanimously.

Councillor Storteboom stated he utilizes thrift stores and is opposed to the bylaw. He does not see a mechanism in the bylaw to determine what portion of goods are donated goods and believes the bylaw comes too late to resolve the saturation issue. He will however, will support the wishes of the DLBA and support the bylaw.

Councillor Albrecht stated Council is not minimizing the importance of thrift stores in the community noting careful consideration has been given to this bylaw.

Councillor van den Broek stated she would like to checks and balances put in place to address the proliferation of all business in the City. The City should be proactive, not reactive to such issues. She believes the community could work together proactively to address unsightly businesses.

Councillor Arnold stated he is opposed to the bylaw.

Councillor Martin stated she is in favour of the bylaw and believes she has heard support of the bylaw from both the DLBA and the community. It is up to neither the City nor the DLBA to police such businesses; if an owner takes pride in their business it will be evident.

CARRIED with Councillor Arnold opposed.

6. <u>DELEGATIONS</u>

a. Vancouver Fraser Port Authority Update

Mr. Cliff Stewart, Vice President of Infrastructure, Vancouver Fraser Port Authority provided information on the following:

- Port Activities in Langley
- Fraser River Improvement Initiative
- Habitat Enhancement Project
- Roberts Bank Terminal 2
- Gateway Transportation Collaboration updated list of potential projects

In response to questions from Council, Mr. Stewart advised:

- He does not believe the Fraser Highway crossing was brought forward for further investigation as part of the Roberts Bank project.
- Reports indicate inland ports need to be located near large population concentrations to be successful and in the American context, this means being located within 500 kilometres of a concentration at least 100 million people although this number would be less in Canada, likely an area similar to Calgary.
- The ECHO program is designed to develop mitigation opportunities for vessels traveling through whale inhabited waters.
- Greenhouse gas emissions are one of the issues being reviewed as part of the
 environmental assessment but the requirements arising from this have not yet
 been determined.

Ms. Knaus presented the results of the community survey and in response to a question, stated:

 All survey responses were from land lines; they attempted to use cellular lines in 2013 but it is very difficult to identify a specific geographical area based on cell phone numbers.

Councillor Albrecht stated he feels improvement needs to be made on the perception of safety in the downtown.

Mayor Schaffer stated he would have preferred a more even representation of responses from the City's six neighbourhoods.

THAT Council allocate \$35,000.00 from the Enterprise Fund to carry out signage, pavement marking and curbing work to re-orient the Rear-In Angle Parking stalls on Park Avenue and the parking lot off Fraser Highway to parallel parking and nose-in parking respectively.

 - 1. Amendment to Flag Raising Policy Rainbow Flag

Motion #16/146 MOVED BY Councillor Pachal SECONDED BY Councillor van den Broek

WHEREAS The City of Langley is an inclusive and diverse community that acknowledges and respects all people regardless of their colour, race, region, national or ethnic origin, age, sex, sexual orientation, gender identity or expression, or mental or physical disability; and

WHEREAS The Rainbow Flag is an international symbol of inclusiveness and diversity; and

WHEREAS The Rainbow Flag is general flown during summer months by municipalities throughout the region, the province, and our nation;

NOW THEREFORE BE IT RESOLVED THAT City of Langley staff amend Council Policy CO-33 'Flag Raising Policy' by no later May 31, 2017 to include adequate and appropriate guidelines and parameters which will result in the flying of a Rainbow Flag for a one week period annually anytime during the month of June or July as an expression of City Council's sentiments.

BEFORE THE QUESTION WAS CALLED

Councillor Martin stated individual members of Council should not be making requests to fly certain flags. She would support a group coming forward to make the request which is permitted under the existing policy. The policy should apply to all organizations, not one specific group.

Councillor van den Broek stateed the rainbow flag and the United Nations flag are the only flags recognized internationally with respect to human rights issues and she does not believe this would single out one specific group and the City should be inclusive for everyone.

THE QUESTION WAS THEN PUT AND

CARRIED with Councillor Arnold opposed.

2. Purchase of Rainbow Flag

The motion was withdrawn.

3. Standalone Courtesy Flagpole

The motion was withdrawn.
