RE: **RCMP raising a divisive political symbol, the rainbow pride flag**

Attention: RCMP Commissioner Brenda Lucki  
RCMP Deputy Commissioner Jennifer Strachan  
RCMP Assistant Commissioner Dwayne McDonald.

I write to you on a very important urgent matter—one that must be resolved by 1300 hours tomorrow, or I will be compelled to mobilize a large and very public protest.

I have learned that the RCMP Surrey detachment, located across the street from the Surrey Provincial courthouse, is going to be raising the controversial, exclusionary and politically charged Rainbow 'Pride' flag on Monday, June 24, 2019.

I urge your immediate reconsideration.

The pride flag represents a sex activist *political* movement that is hostile to free speech, to parental rights, and to freedom of assembly; and is currently targeting children with an extremist transgender and sexual orientation agenda through the public education system.

Upon further research, the practice of raising this flag over various RCMP detachments has been done in violation of the Supreme Court of Canada ruling that government institutions must remain neutral; furthermore, it has in every case willfully ignored the public outrage posted on social media, and thus shows contemptuous disregard for the citizenry, the law and for statutory regulations prescribing the conduct of the RCMP and its members.

Please review the stipulations found in your *Code of Conduct*.

**RESPECT AND COURTESY**

2.1 - Members treat every person with respect and courtesy and do not engage in discrimination or harassment.

As a person who has received numerous death threats, rape threats, disgusting hard core pornography, threats against my children and grandchildren from rainbow 'Pride' flag-carrying sex activists, I find the flying of this political symbol of hostility and violence by the RCMP to



be utterly devoid of any form of respect for my views and those of millions of other Canadians. It also sends an unmistakable message that the RCMP advocates, aligns with and promotes the anti-Canadian politics and ideologies associated with the Rainbow 'Pride' flag. This conduct is a direct violation of your statutory duties as stated in 3.1.

### ***RESPECT FOR THE LAW AND THE ADMINISTRATION OF JUSTICE***

3.1 - Members respect the law and the rights of all individuals.

3.2 - Members act with integrity, fairness and impartiality, and do not compromise or abuse their authority, power or position.

How is flying the 'Pride' flag "impartial"? How is raising a flag whose own creator declared it was to be used for "proclaiming power" respecting all individuals? Clearly, you are either unaware of the growing opposition to the sex activist political hijacking of our nation—or you are willfully complicit.

The RCMP has a duty to remain neutral. I appreciate that there is an attempt to right wrongs of the past, and that some of your more naïve members may succumb to propaganda that associates protection of youth with manufactured, bogus statistics that have been carefully designed to blind otherwise logically-thinking people; but raising the flag of a group that is hostile to the pillars upon which our nation is built exceeds those laudable goals, and instead violates the institutional importance of the RCMP.

The decision to fly the Rainbow 'Pride' flag is a blatant attack on those who do not acquiesce to the bully tactics of the sex activists and/or their propaganda machine.

7.1 - Members behave in a manner that is not likely to discredit the Force.

Is he manufacturing problems? I appreciate that those sex activists, some within the RCMP, that fly the rainbow flag to publish their political agenda, fear the uniting of our diverse cultures. Those activists within the RCMP should constrain their desire to abuse their position and **NOT** engage in attempting to intimidate groups who have every right to be informed and empowered to protect their children, protect their religious beliefs and protect the true diversity of our nation. I checked the BCMA events calendar, and this event isn't listed...can you make any inquiries about whether this event took place, or direct me to someone who can?

My recorded conversation with Corporal Statham after being notified of his antics is even more disturbing. The conduct of Corporal Statham warrants an investigation. Perhaps it is prejudices such as his that restrains my ability from having hate crime charges brought against those who willfully engage in campaigns designed to vilify, incite hatred and contempt against Christians.

By raising the rainbow flag, the RCMP will deliberately violate their own published Mission, Vision and Values statement that supposedly guides the RCMP, as well as your statutory directives. The conduct of the RCMP in this matter is overtly discriminatory and foolish; and is creating an environment of hostility, exclusion, mistrust and upset.

I know that the media's bias in matters relating to sex activism prevents them from presenting an accurate reflection of the public's sentiment, but the RCMP should **not** be assessing public opinion by a gay-dumb and compliant media. The silent majority is rising. Recent events here in British Columbia—one as recent as June 15, 2019—tell a very, very different story.

On June 15, 2019, hundreds of British Columbians gathered on the steps of the Vancouver Art Gallery to put an end to transgender extremism, gay privilege and the assault on children. The political campaign by sex activists to compel citizens in a free society to play in a game of forced delusion will ignite a revolt. Lying to children about their gender will cause people to rise up. Undermining parental authority and recruiting children into a political agenda that worships and marches under a Rainbow 'Pride' flag will be met with widespread public resistance.

These unsavoury politically-motivated trends must not be allowed to impugn the once-proud reputation of Canada's national police force. It is imperative that the RCMP protect its impartiality. Flying this political symbol does exactly the opposite.

It is a given that every attempt by civil Canadians to bring truth and expose the issues that negatively impact the standard narratives associated with LGBTQ+++ propaganda is always



met with organized opposition by the radical sex activists that is designed to shut down lawful meetings, impede free speech and silence important discourse. The opposition carries out their assaults upon our freedoms under the rainbow flag. With military precision they scream through bull horns, engage whistles and other noise devices, assault people with their signs, engage in vulgar expletives all under their political colours, their flag.

***The Rainbow Pride flag is exclusive, divisive, offensive and hostile to civil Canadians.***

This issue is a very serious one I suggest that somber reconsideration be given to this event and that it be cancelled forthwith. Further, that the RCMP cease from flying the rainbow flag or any other identifiable group flag at all detachments.

I should inform you that I have a live case before the BC Human Rights Tribunal involving Langley City and their decision to fly the rainbow flag and discriminate against my Christian flag by refusing to fly it. I will not hesitate to engage in legal action if required.


I apologize for the confrontational nature of this correspondence, but the politicization of the RCMP by anti-Canadian sex activists who are targeting our rights, our freedoms and our children—a hostile and dangerous political movement identified by the Rainbow ‘Pride’ Flag—is worth confrontation.

I ask that you contact me tomorrow by reply email no later than 1300 hours, and provide me with confirmation concerning the scheduled event, either way—Yes, it is going ahead; Or, it has been cancelled. It should be noted that the City of Surrey will not be raising the pride flag, recognizing the hostility and divisiveness it signifies.

If the event proceeds, I will organize a protest. I will also publish information concerning one of the invited groups that will not bode well for the RCMP.

On behalf of Canadians who stand with me I wish to thank your members who serve our nation with courage and integrity. It is my hope that serious consideration will be given to ending the practice of raising pride flags above RCMP detachments.
