I require you to act in accordance with the law and provide me with exemption from being forced and/or coerced into participating in an experimental program that violates my rights, including the right to abide fully in life, the right to work, and freely exercise my protected rights as a Christian to refuse medical treatments that violate the tenets of my Christian belief.

1. As a Christian I am prohibited from injecting toxic substances into my body, as my heart, soul and body belong to God. The Word of God states, 1 Corinthians 3:16 -17: ***Do you not know that you are God's temple and that God's Spirit dwells in you? If anyone destroys God's temple, God will destroy that person; for God's temple is sacred, and you together are that temple.***

As you must know, the identified ingredients of the COVID-19 mRNA intervention (misidentified as a 'vaccine') contains chemical substances that are toxic to the body. My belief prohibits the deliberate introduction of poisons into my body, God's temple.

2. As a Christian I am required to make informed decisions. Proverbs 18:17 states: ***The one who states his case first seems right, until the other comes and examines him.***

I am informed, educated and have the ability to acquire, research and make informed decisions that are in compliance with the dictates of my religious beliefs. In keeping with the instructions dictated in the **Word of God**, I have examined and questioned the COVID-related published information and Public Health Officer's (PHO) directives. I have found, upon examination, that the PHO is not being forthright in the delivery of proper statistical information, and have engaged in manufacturing creative definitions of words like "vaccine" and "vaccination" that redefine the accepted definitions; and has failed to be honest about the efficacy of the vaccine and harm it is sometimes causing.

3. As a Christian I am commanded in Ephesians 5:11 to ***"Have nothing to do with the fruitless deeds of darkness, but rather expose them."*** Proverbs 24:11 requires me to ***"Rescue those who are being taken away to death; hold back those who are stumbling to the slaughter."***

Deception, harm, lies, coercion, blood clots, strokes, death... are "deeds of darkness". I am prohibited from taking any part in this experiment. I am instead required to expose these deeds. Further, I am commanded to save those who are blindly "stumbling" to participate in an experimental exercise that has led to death, harm and long term affects that we still don't know about. I must be exempted.

4. As a Christian I am commanded to respect and protect the sanctity of life. Psalm 139:13-14 states: ***For you formed my inward parts; you knitted me together in my mother's womb. I praise you, for I am fearfully and wonderfully made. Wonderful are your works; my soul knows it very well.*** Psalm 127:3 informs us that, ***"Children are a heritage from the Lord, the fruit of the womb a reward."*** Exodus 20:13 commands, ***"You shall not murder."***

As you are aware. The COVID 'vaccines' were developed using testing methods that include the use of cell lines originally taken from the corpses of murdered babies. I know most people sanitize this practice by using

the term “abortion”, but in reality, it is the deliberate murdering of a child—a pre-born human being. As a Christian, I cannot participate in any form of practice or therapy that has utilized at any time the cells of a murdered child. I must be exempted.

5. 1 Corinthians 6:19-20 first questions us and then informs us about our duty to bring glory to God through our bodies. ***“Or do you not know that your body is a temple of the Holy Spirit within you, whom you have from God? You are not your own, for you were bought with a price. So glorify God in your body.”***

As a Christian, I acknowledge the price Christ paid for my sins. My body belongs to God. My body is **His** temple and you are prohibited from experimenting on “His temple”. Most importantly, I cannot consent for God, who according to his word, owns my earthly vessel.

Lastly, I am aware that the PHO often quotes awareness of their duties when giving consideration to the *Canadian Charter of Rights and Freedoms* and the protections found therein for all Canadians, even when issuing edicts that infringe on those rights. The PHO’s blatant disregard for the guiding principles established in the Preamble of the *Charter*, when considering lawful accommodation to provide exemptions for those who maintain an adherence to their religious beliefs, can no longer be ignored. especially when it comes to providing exemptions for those whose religious beliefs prohibit compliance to injecting experimental toxins. Specifically: ***“Whereas Canada is founded upon principles that recognize the supremacy of God and the rule of law”***. Your edicts do not triumph over those who abide in recognizing the ***Supremacy of God***. The ***“Rule of Law”*** is unequivocally adjoined to that fact.

I submit this request for an exemption from any and all adverse consequences relating to my workplace and/or employment. I ask my union to properly protect my rights as a Christian from procedures that the Public Health Officer have initiated in response to COVID-19 and its variants.

Please provide me with this written exemption as soon as possible, in order to mitigate the damage already caused, and the abusive effects that continue to inflict harm, job loss, restrictions on mobility, etc.
