- BC RCMP Headquarters event Drag queens, provocative table-top dancing, and Pride activist, member on leave, Elenore Sturko, MLA
- RCMP officers indoctrinating kids with Pride propaganda- The Out on Patrol Society
- > Failure to uphold the RCMP Code of Conduct, breach of trust/respect
- Your resignation, or apology

Dear Sir,

I write to request information on your involvement, as Commanding Officer for the RCMP in BC, in sanctioning the use and participation of the taxpayer-funded RCMP headquarters in Surrey, BC.

This troubling story first reported on by the Western Standard, when WS's respected

journalist, Lee Harding, received a <u>video</u> record of an event held on June 14, 2023, at the RCMP headquarters in Surrey, BC.

The video recorded one of the featured acts, a "drag show." The recording shows a man, degradingly and offensively impersonating a skankily dressed woman, dancing in a sexually provocative manner on the tables located in the "mess hall" of RCMP HQ.





Aside from the health issues of someone's boots and near naked butt greasing tables typically used for RCMP member's eating, I would like to know the answers to a few questions.

Questions: Who paid for this "event"? Who authorized the use of RCMP headquarters for it? Did the organizing group Out on Patrol society rent the facility or was it provided free of charge? Did those employed by the RCMP who attended get paid for attending? Is mocking, sexualizing and degrading women a form of entertainment acceptable to the RCMP? Do biological female pole dancers have access to the "mess" hall too? Lastly, did you attend?



According to the promotional material, in addition to the drag show, former RCMP media liaison officer for Surrey, Sgt. Elenore Sturko was a featured speaker. I appreciate Sturko has taken leave from the RCMP to facilitate her new found career as a politician, and elected representative for the formerly known BC Liberal party, now renamed the BC United (AKA "Unicorn party" due to their promotion of "trans" sex activism), a political party that is responsible for bringing into schools the despised and dangerous SOGI123 program, a "learning resource" that is provably abusive to children. As you can appreciate, providing a PRIDE activist politician the opportunity, and platform, to make a presentation/speech at

RCMP HQ requires clarification. One can only conclude that it appears that the RCMP is endorsing a political party as well as the pride political agenda.

Questions: Was the RCMP headquarters, a facility required to be neutral on political matters, used unlawfully to give a special opportunity to promote one provincial political party? Are there events scheduled for John Runstad, an elected representative for the Conservative Party of BC, or the Greens...the NDP? Is there a recording of



Sturko's speech? If so, will you provide me with a copy? I am curious, how do I get my organization authorization to use this facility for political purposes?

The RCMP drag event promotional information, and social media postings advertising it, indicate that at least 2 drag queens attended. One named Mz Adrien was there to "host" and that "drinks" were going to be available. The event promo advised that up to 2 drinks were to be free if a membership to a highly questionable lgbtq+++ pride political action group called the "**Out on Patrol Society**" was purchased, or if you were an existing member.

Questions: Did any of these drinks contain alcohol? Is RCMP headquarters licensed to serve alcohol? For those not entitled to "free drinks," were there drinks available for purchase? If so, where did the money go? If alcohol was available, did people get behind the wheel of a car after 2 drinks? Who monitored those drinking to make sure they didn't drive?

I trust you remember meeting me. We first met in person in June 2019, outside the RCMP detachment that is situated directly across from the provincial court house in Surrey. You might recall the gathering of concerned citizens, the occasion involved a



protest that was organized as a result of your decision to raise the "Pride" flag, a flag that is a political symbol of a divisive, dangerous, political movement that is abusing children, undermining our civil society, and corrupting the ethical application of our public service values and codes of conduct.

This link will take you to the video

of that day's event, it records how you stood by and allowed sex-activists to block us, spew lies, incite contempt and blow whistles trying to disrupt our peaceful protest. Do you know how many officers quietly thanked me that day? Lots.

This protest outside your detachment, if you recall, was a direct result of my <u>letter</u>¹, dated June 20, 2019, requesting your reconsideration of raising the Pride flag above the front entrance to the RCMP detachment in Surrey, a flag that would signify the RCMP's alliance to this political movement and violate the mandate of the RCMP to respect all people.

In my letter I reminded you of your responsibilities to serve all Canadians with respect, your duties as directed by the RCMP code of conduct and your lawful duty to remain neutral. I quoted directly from the RCMP's code of conduct:

The RCMP Code of Conduct states:

Statement of Objectives of Objectives

This Code of Conduct sets out responsibilities, consistent with section 37 of the Royal Canadian Mounted Police Act, that reinforce the **high standard** of conduct expected of members of the Force.

1 APPLICATION

1.1 This Code applies to every member of the Force and establishes responsibilities and the standard of conduct for members, on and off duty, in and outside Canada.

2 RESPECT AND COURTESY

2.1 Members treat every person with respect and courtesy and do not engage in discrimination or harassment.

3 RESPECT FOR THE LAW AND THE ADMINISTRATION OF JUSTICE

3.1 Members respect the law and the rights of all individuals.

3.2 Members act with integrity, fairness and impartiality, and do not compromise or abuse their authority, power or position.

6 CONFLICT OF INTEREST

6.1 Members avoid actual, apparent, or potential conflicts between their professional responsibilities and **private interests**.

7 DISCREDITABLE CONDUCT

7.1 Members behave in a manner that is not likely to discredit the Force.

Back in June of 2019, you ignored my request for reconsideration and compliance to your legal duties, instead decided to violate the RCMP's Code of Conduct and the direction of the Supreme Court of Canada that government institutions/building must remain neutral.

You also violated the Royal Canadian Mounted Police Act,² specifically section 37:

Responsibilities

37 It is the responsibility of every member

- (a) to respect the rights of all persons;
- **(b)** to maintain the integrity of the law, law enforcement and the administration of justice;
- (c) to perform the member's duties promptly, **impartially** and diligently, in accordance with the law and without abusing the member's authority;
- (d) to avoid any actual, apparent or potential conflict of interests;
- (e) to ensure that any improper or unlawful conduct of any member is not concealed or permitted to continue;
- (f) to be incorruptible, never accepting or seeking special privilege in the performance of the member's duties or otherwise placing the member under any obligation that may prejudice the proper performance of the member's duties;
- (g) to act at all times in a courteous, respectful and honourable manner; and
- (h) to maintain the honour of the Force and its principles and purposes.

With intent you allowed the Pride political flag on June 24, 2019, to be raised and in doing so facilitated a public declaration of political alliance between Pride activism and the RCMP. The RCMP, in breach of their own rules, endorsed a political movement that manufactures division, incites hatred, contempt, chaos, promotes child abuse and child endangerment among other anti-democratic actions.

I now know that my letter resulted in some discussions between you and the then RCMP commissioner Brenda Lucki. This information, if true, compounds the concern about your conduct and that of the RCMP's highest ranking officer at the time.

You might be interested to know that I have obtained a video of Sgt. Sturko doing a pro pride prep talk to students while she was a still active member. I wonder, is in now the required practice of the every RCMP member to disclose/discuss their sexual practices to children, or just members wanting to advance pride politics? Perhaps there is a new

RCMP directive the public is unaware of, a requirement to adopt pride speak; "I'm officer so and so, my pronouns are ..., You'll know by my disclosure to being a "lesbian", "pansexual", "gay", "dog master" or ... that I engage in certain sexual activities and with whom."

The use of pronouns and pronouncement of sexual identity/practices are sex activist tactics. The RCMP, and its members, should not be engaged in this political ploy. Pride speak is political speak.

<u>Question</u>: Do you in your professional capacity identify yourself by your sexual practices? Do you use pronouns in your official duty to demonstrate political coding of your allyship to the pride political agenda?

During her interview for the students, Sturko engaged in the typical sex activist talk, identifies her personal struggles as a lesbian... Sturko then identifies the situation involving the raising of the pride flag in 2019 over the Surrey detachment as a pivotal moment in her life and you had a star role is the account. She informs the students that she was the catalyst for this occasion and then she tells them that she was advised that there were "threats" made, she crafts a message to the students of how fearful she was for the safety of those invited to the flag raising event. Is Sturko delusional? Sturko then speaks about her telephone conversation with you and how you relayed the conversation you had with then Commissioner Lucki. You supposedly informed Sturko that Commissioner Lucki had stated, "I know about the protest, of course we're going to raise the flag, we're not going to let someone bully us..."

Sturko goes on to manipulate the emotional draw from the students of her victimhood. She states that while attending the flag raising and the protest that "she never felt so much hatred…" Of course, this is a perfect example of the common strategies

associated with pride propagandized messaging. Taking advantage of her position and exploiting students is not acceptable. The truth is that **you** violated the *Act* governing the RCMP and the RCMP's own Code of Conduct when you agreed to fly the flag. **There was no bullying**. "Yes," there was a demand by the people you serve to adhere to the rules and not acquiesce to the manipulations of sex activists. have been a protest. You failed in your duty, and Sturko lied to the kids. She manipulated them to serve her own political and personal interests.

The events that recently became public about the activities within the RCMP headquarters in Surrey involving drag queens, sexualized table-top dancing by a man mocking women, and having pride sex-activist Elenore Sturko, an individual who is willing to deceive students to further her political goals, be a guest speaker demonstrates one of three situations:

1. You are committed to using your power within the RCMP to advance a destructive and dangerous PRIDE political sex-activist agenda that violates the very statute, and defined conducts you are governed by as a member of the RCMP. An agenda dedicated to "Queering" the RCMP.

- 2. You are ignorant and fail to comprehend the tactics of this political movement to capture and deceive the emotionally gullible and to bully and abuse anyone that fails to embrace the PRIDE activist political movement.
- 3. You are a coward and are wilfully turning a blind eye to this abuse of the RCMP organization and those under your command. Instead of standing up to the pride activist bullies and maintaining proper conduct of your command, you remain silent, failing to exercise proper leadership in curtailing this abuse of the RCMP as a once respected institution.

Question: Please inform me as to which of the scenarios presented above is most accurate and explains the past flag raising event and the current situation involving drag queen and political promotion of the pride political agenda?

During my investigation into this obscene abuse of the public's trust and expectations of the RCMP, there are questions that need answers concerning the RCMP's support and involvement of pride activist members within the RCMP that are also members of the "Out on Patrol Society" (OoPS). It appears OoPS is a separate organization, constituted as a non-profit, with a board of directors. It is supposedly independent from the RCMP, yet inappropriately entwined, unless of course there are signed agreements between the RCMP and OoPS stipulating co-run activities.

According to the promotional material OoPS, and the RCMP members who hold membership in that organization, appear to be the instigators responsible for creating the drag/ political event held at RCMP headquarters, of course, they required your permission to hold it there. Deputy Commissioner Mc Donald, are you a member of

OoPS?

For the record, while there could be some amusement in the relating of this situation as a "big oops, we messed up", the OoPS political strategy is clever, and is not accidental.

As Commanding officer for the RCMP in BC please respond to the following:

- 1. Please provide me with all written agreements/contracts or MOUs made with OoPS to provide permission to use the RCMP branding, uniform or any other associated image in carrying out their objectives.
- 2. Please clarify; When members of the RCMP provide information sessions to students in BC schools on matters related to the pride political activists' versions of LGBTQ+++++ issues under the banner of the OoPS, what is the approved message? Example, the picture above states that 650 New Westminster students were exposed to "2SLGBTQI+ issues." What are these "issues"? Is there a recording of these events? Are students fully informed on matters related to LGBTQ+, or presented with the twisted version of pride sex activists? Is there "approved" material for use?
- 3. Please provide me with access to this information and/or copies of all materials used and/or distributed, including PowerPoints, recordings and contracts with the schools.

- 4. Concerning the above picture, were these officers, and others making presentations throughout the province, paid by the RCMP (taxpayers), OoPS, or did they volunteer their time?
- 5. Please advise, are parents informed that members of the RCMP participating in these school-based events are involved with an lgbtq++++ political action group (OoPS) embedded within the RCMP, or are they misled as to the intent of these presentations?
- 6. As you can see in the above picture, one of your officers, Jace Rondario advertises PRIDE political alliance to gender ideology by publicly "identifying" as "They/She and SIYA" on social media. How does this officer justify advertising a political alliance to a political movement to students while wearing the RCMP uniform? Did this individual get permission from the proper authorities to piggyback political sex activism on the earned trust of the RCMP in schools and on social media? If so, who gave the required permission?
- 7. PRIDE is political, it is a multibillion-dollar industry that is funded mostly through government grants. There is growing concern that these grants may be illegal and being used fraudulently. How can Canadians have any confidence in the investigative process involving the RCMP when there is evidence of political promotion and collusion with sex activist operatives within the RCMP?



8. The OoPS, and those RCMP members representing this "society," promote their involvement with the **Public Service Pride**, a questionable political movement within the federal public service dedicated to "queering" all departments by indoctrinating federal workers with the 2SLGBTQ+ agenda and coercing compliance to their political overtake from within. According to the announcement

on Twitter, the OoPS has been nominated for an award by this politicly driven agency, Public Pride Service.

Question: Why would you allow members of the RCMP to be visible representatives of an organization that receives an award from a political action group acting contrary to the public service lawful requirement of being non-partisan?

8. The RCMP is also complicit in promoting scholarships to students if they are willing to declare their sexual orientation as being anything other than



heterosexual. Getting a financial reward for "declaring" one's sexual preferences and/or identity before the brain is even fully developed is manipulative.

Questions: Why would the RCMP do this? Did you authorize members of the RCMP to act in collusion with the OoPS to engage in this discriminatory and potentially dangerous manipulation of

students? Did you authorize members addressing school presentations to promote this scholarship program? Are you that ignorant about the destructive trend of sexual "fluidity" in students? How do you think other students feel who don't meet the criteria of being LGBTQ+++? What about financially struggling families, 4k is a lot of money, is the RCMP incentivizing kids to lie about their sexual orientation?

9. With concern to the above, the small print in the scholarship application uses the tactics of inciting "victimization." It reads: "

As members of the 2SLGBTQ+ community, we are aware of the challenging reality of being publicly "out" at a young age. We will be

sensitive to each individual's circumstances and work with them on an announcement strategy in a way that makes them comfortable.³

Question: Why is the RCMP not only outing vulnerable kids, but facilitating the psychological conditioning tactic used by pride activist of assigning victimhood to students? Shouldn't the RCMP be mentoring a positive culture within our civil society that promotes merit, hard work, mental health, and character rather than engaging in the identity politics of division that provides privilege based on race, colour, sexual proclivities, mental illness and how one feels/identifies on any given day?

10. There is evidence that Motorola Solutions, a corporation that receives millions of dollars worth of government-awarded, RCMP contracts, has provided ongoing grants to OoPS to facilitate RCMP PRIDE activists the ability to access students and promote PRIDE politics. There is evidence that RCMP PRIDE activist members provide enticement to manipulate students into embracing PRIDE with free PRIDE related swag and financial award through a discriminatory-based scholarship program funded by Motorola Solutions.

Questions: Are RCMP officers permitted to dress in their uniforms while working for an outside political organization like OoPS? Who paid the RCMP officers for showing up in their uniforms to deliver a pro pride political indoctrination sessions on behalf of the OoPS and marketing the Motorola Solutions scholarships?

11. Motorola Solutions – Conflict of interests...Influence peddling? The optics are not good, the implications worse. Example, May 2022, the RCMP issues a media release concerning the contract for purchasing body worn cameras.⁴ According to the release Motorola Solutions was competing for the contract to supply these cameras to the RCMP. Not only did Motorola Solutions win the contract, but according to an analysis of the government of Canada's contracts, done by



Carlton University School of Public Policy, the RCMP, in 2021-2022, engaged in contracts worth \$606.6M.⁵ According to the research, Motorola Solutions was the 3rd highest paid contractor for that year, receiving \$35,678.18, in awarded contracts from the RCMP, and got paid more than General Motors.

Question: Did you know about numerous contracts Motorola Solutions bids on to supply the RCMP with their products? Did you know that RCMP members, through their work with OoPS, are being provided with tens of thousands of dollars? What due diligence have you done to ensure the multimillion-dollar contracts are not being awarded to PRIDE activist friendly corporations like Motorola by PRIDE activists within the "<u>Public Service Pride</u>", the same organization wanting to give OoPS an award. The same organization that has weaponized, perhaps unlawfully, the public service to give preferential benefit to "qualifying" "pride friendly" diverse corporations. Are you aware of the "50-30 Challenge"?

12. According the RCMP's directive on use of the RCMP image,⁶ it is a prohibit use for members to engage in activities where it could be perceived as advertising or recommending a private individual's or business's products or services.

Question: Have you given permission to the RCMP members who are actively engaged in participating in OoPS events (pride parades, public events, school events while wearing and exploiting the protected images and uniform of the RCMP), including the promotion of a business funded scholarship, namely Motorola Solutions, to use the protected images? If so, for what purposes? Will you provide me with any existing



written permissions given to OoPS, and/or Motorola Solutions and/or any member who sought permission to wear their uniform in conjunction with pride related events and/or OoPS related events?

13. RCMP members act as if OoPS is an extension of the RCMP, thus linking the RCMP directly to promoting organizations like the ARC foundation, the group behind the notorious SOGI123 program that is destroying children and their families in some cases. As you can see, this screen capture from the OoPS Facebook page links this public-school event links the RCMP to OoPS, the SOGI123 lead, and PRIDE through the distributing of enticements, "swag," like pride political glasses. The post clearly identifies all this activity to "as part of the @motorolasolutions foundation."

Questions: SOGI123 goals include undermining parental authority, deconstructing the identity of children as young as 3 years old and promoting the transitioning of children; Do you, as one of our highest-ranking law enforcement

officers in BC, support these goals? Do you support genital mutilation, placing children on puberty blockers, making the youth sterile?

Have you, or any of your underlings, entered into any agreement with the ARC foundation, aka SOGI123 leads? If so, will you provide me with a copy of that agreement?



14. From the published pictures it seems clear that RCMP officers engage often in public events in collusion with OoPS. There is record of your officers recruiting children at "Kidsfest" enticing them with swag, pride decorated sunglasses, etc.

Question: Do you endorse and support the introduction ad recruitment of children and youth into the pride political movement through exposure to the activist members within the RCMP?

15. I see from the OoPS website that there is opportunity to secure corporate speaking sessions from members.

Question: To the best of your knowledge has there been any OoPS bookings made by any RCMP affiliate to facilitate a presentation by members of OoPS? How many RCMP members are involved in giving these presentations? Who are they? What information

is presented and to whom have they presented?

16. The challenge before you Deputy Commissioner McDonald, is that this isn't the first occasion I have to provide evidence of your pride activism. The actions of RCMP officers involved in OoPS related events must have been sanctioned by you. Manipulating children, and allowing the trust Canadians have in the RCMP organization to be abused is a serious overstep, so serious that it requires your resignation.

Question: Will you resign? Will you apologize?

17. Allowing the headquarters of the RCMP to become an arena for the denigration of women, perversion of members and abuse of those who must work there and be subjected to your sanctioned sexual antics and political saturation of "pride" activism with the corridors of Green Timbers E Division Headquarters demands your resignation.

Question: Will you resign? Will you apologize?

18. I will be moving forward this time with complaints to the appropriate offices. I trust that you will respond to my questions, but in case you fail to respond I will seek as much information as possible through freedom of information.

If you refuse to resign, my best hope is that you review what has happened and cease the facilitation of this destructive agenda pending any investigations into what has been transpiring within the RCMP. Pride is political, it destroys children, civil society and deconstructs the pillars upon which our nation has been built. The RCMP has no place in aiding this political agenda.

Oath of Office: "Do you solemnly swear that you will faithfully, diligently and impartially execute and perform the duties required of you as a member of the Royal Canadian Mounted Police, and will well and truly obey and perform all lawful orders and instructions that you receive, without fear, favor or affection of or towards any person, so help you God?"

The RCMP Oath of Office demands restraint from unlawful engagement of political agendas. The sex activists "PRIDE" agenda is responsible for the abuse of children, undermining of parental authority, aiding an industry built upon genital mutilation, the devolution of our civil society, tax-payer abuse and the deliberate incitement of hate and contempt for those who are willing to expose this deconstructionist tool designed to undermine democracy.
