## *Multi-pronged approach*

### 1. BC Human Rights

Public schools have become the politicized battlegrounds for sex activism and those seeking to alter our culture. Parental rights are no longer respected, and for many children the classroom has become a threat to their identity, values, morals and religious beliefs.

Increasingly parents are removing their children from the dangers of public education, others are looking for alternatives.

Currently the funding formulas are discriminatory. Children are penalized for seeking better alternatives for education.

***This must end.***

A complaint will be filed with the BC Human Rights Tribunal seeking to end discriminatory funding. Children and their parents should not be punished for seeking a proper education, in a healthy and supportive environment.

### 2. Recall and Initiative Act

British Columbians have the power to unite and force the government to act. "Initiative" petitions must acquire signatures of 10% of registered voters in each of the 87 electoral districts over a 90-day period. 4, maybe 5 "petitions" will be activated.

1. **STOP SOGI**
2. Government Identification ***must*** reflect an individual's biological assignment/reality.
3. Public decency law to ***protect*** the privacy issues of public washrooms and changeroom. Usage must correlate with biological assignment.
4. ***Prohibit*** of any form of government funding to businesses or organizations that engage in the creation, distribution, publication or public display of nudity, sex acts or lewd behavior(s).
5. Respect Act – ***requires all*** government agencies, buildings, schools, roads, vehicles and/or facilities to refrain from displaying any form of political symbol other than the Canadian and provincial flags or related emblems. Therefore, ***no Pride Flags or rainbow sidewalks.***

### 3. Legal

Culture Guard has retained the services of Dr. Charles Lugosi and his firm, Crease Harmon LLP. Dr. Lugosi is a highly respected litigator and Constitutional expert.

Legal action will commence once we are certain that we can fully fund the legal case. A retainer of \$250,000. is needed. Anticipated costs will be \$3-5 million in total legal fees, less if the "Initiative" is successful. ***Protecting our children and nation has a cost.***

Strategy - We will target the BCTF for exceeding their authority in the classroom and for abusing the schools for a political purpose. A separate suit will be filed as a class action suit against the Ministry of Education for child endangerment, breach of duty, breach of trust...etc..
