Kari Simpson runs an organization called Culture Guard that has created protests and hatred towards the LGBTQ2SIA+ community with protests against the LGBTQ, SOGI 123 and more. As a transgendered individual, Kari Simpson has targeted me with hatred. The main issues of this claim is that Kari Simpson is exhibiting hatered, and spreading that hate over social media due to me being transgender. She refers to me purposely as 'Jonathan Jessica Yaniv' in her social media posts, knowing that I have changed my name legally to Jessica Yaniv. She also purposely uses the wrong pronouns in an effort to hurt, and spread hate towards me, referring to me, a female, as "he/him/his." Using the wrong pronouns towards a transgendered individual is a hate crime. Purposely using the wrong pronouns constitutes discrimination and criminal harassment. Not using the right pronouns on purpose is gender-based harassment. I reference a 2014 policy released by the Ontario Human Rights Commission (OHRC). Page 18 reads: "Gender-based harassment can involve: (5) Refusing to refer to a person by their self-identified name and proper personal pronoun." Federal guidelines mirror the provincial policies. Kari Simpson's purposeful misgendering and using the wrong pronouns is not an accident. Bill C-16 added the words "gender identity or expression" to three places. It was added to a section of the Criminal Code dealing with sentencing for hate crimes. If there's evidence that an offence is motivated by bias, prejudice or hate, it can be taken into account by the courts during sentencing. As such, I am asking for damages
